GOLDENROD OUTSTANDING SCHOOL BUSINESS OFFICIAL AWARD

Each year the Kentucky Association of School Business Officials at the Annual Conference and Exhibits will recognize an outstanding KASBO member who exemplifies professionalism, leadership, and innovation in the field of school business management.

The award winner will also be recognized by the Southeastern Association of School Business Officials at its Annual Conference. KASBO will send its Award Winner's name to the SASBO Executive Secretary no later than April 1 of each year. The SASBO Executive Secretary will work with the past ASBO International Eagle Award Recipients in contacting the KASBO Award Winner and assisting those interested in applying for the ASBO International Eagle or Pinnacle Awards. A team of past Association of School Business Officials International Eagle Award Recipients from SASBO will assist KASBO's Outstanding School Business Official, if he/she is an ASBO International Member and is interested in preparing an application for the ASBO International Eagle or Pinnacle Awards.

GUIDELINES:

Any active member of KASBO or the nominee's Superintendent may submit nominations for the Goldenrod Outstanding School Business Official of Kentucky Award to KASBO by submitting the following information:

- A description of the nominee's service to their school district, their profession, their colleagues, and (optional) their communities by completing this official Nominee Application.
- Three letters of recommendation, at least two of which directly address issues concerning the nominee's activities and career as a school business official. Letters of recommendation from Business Associates (Vendors) are discouraged.
- Additional information regarding the nominee, if appropriate, on a separate sheet.

The completed application and attachments must be submitted to the KASBO designate (see below) on or before February 1 of each year.

Nominees for the Goldenrod Outstanding Business Official Award must be employed by a Kentucky public school district and must be a current active KASBO member, who has been a KASBO member for at least five years. An active KASBO member may self-nominate. Current KASBO officers, KASBO board members, and KASBO Goldenrod Outstanding School Business Official Award Committee members are not eligible.

A committee established by the KASBO Board will review nominees objectively. The committee reserves the right to request additional information on any nominee. Each nomination will remain valid and kept on file for three years, unless withdrawn by either the nominee or nominating party.

KASBO's designate will assume responsibility to notify the Superintendent and/or family of the successful candidate and invite them to attend the presentation of the award. The names of candidates submitted and the selection of the successful candidate will be kept in strict confidence.
