

# KENTUCKY ASSOCIATION OF SCHOOL BUSINESS OFFICIALS (KASBO)

## GOLDENROD OUTSTANDING SCHOOL BUSINESS OFFICIAL AWARD INFORMATION

- Has a school business official in Kentucky assisted you, mentored you, encouraged you, or been a role model for you? If so, this is your opportunity to acknowledge the impact he or she has had on your professional life and to say thank you.
- Do you know a school business official who has done an outstanding job for his or her district and our profession, making it a better place for children to learn? If so, this is your chance to see that the individual's contribution is recognized.

The Kentucky Association of School Business Officials wants to recognize outstanding KASBO members who exemplify professionalism, leadership, and innovation in the field of school business management. This recognition is called the Goldenrod Outstanding School Business Official Award. It is given annually to an individual who best represents exemplary practices and standards of school business in a Kentucky public school district. Our state winner will also be recognized by the Southeastern Association of School Business Officials at its Annual Conference. We encourage you to nominate one or more individuals whom you believe are deserving of the award. You may self-nominate as well. We encourage you to share this information with your superintendent because he/she is eligible to nominate someone from your district.

The recipient will receive the following:

- Presentation of the award will be made at his/her local school board meeting.
- An appropriate commemorative item will be given.
- A presentation will be made at the KASBO conference.
- Expense-paid trip to the SASBO annual conference is included, courtesy of KASBO, with recognition at the SASBO General Session and an award winners' breakfast.
- \$1,000 scholarship will be funded by KASBO to be awarded by the recipient to a deserving student in the recipient's district. Student selection will be determined at the discretion of the KASBO award recipient.
- Assistance from a SASBO member in applying for an ASBO International award is available, if desired.

Attached are the guidelines and link for nominating an individual for the Goldenrod Outstanding School Business Official of Kentucky Award. Please note that April 7<sup>th</sup>, 2017 is the deadline for nomination applications. All submitted applications will remain on file for an additional two years, unless withdrawn by the nominator. If you submitted an application three or more years ago for someone who has not been chosen, that person needs to be re-nominated in order to be considered for the award now.

## **GUIDELINES:**

Any active member of KASBO or the nominee's Superintendent may submit nominations for the Goldenrod Outstanding School Business Official of Kentucky Award to KASBO by providing the following information:

The completed application must be submitted on or before April 7, 2017.

Nominees for the Goldenrod Outstanding School Business Official Award must be employed by a Kentucky public school district and must be a current active KASBO member who has been a KASBO member for at least five years. Current KASBO officers, KASBO board members, and KASBO Goldenrod Outstanding School Business Official Award Committee members are not eligible for consideration.

A committee established by the KASBO Board will review nominees objectively. The committee reserves the right to request additional information on any nominee and to not name a winner if an insufficient number of nominations are received. Each nomination will remain valid and kept on file for three years, unless withdrawn by either the nominee or nominating party.

The award will be presented to the successful candidate at a School Board meeting in his/her home district whenever possible.

We have many deserving people in Kentucky, and this is your opportunity to see that their efforts are recognized. I hope that you will take the time to do this on their behalf.
